The undersigned (hereinafter called the Applicant) hereby applies for membership in and agrees to purchase electric energy from the PLUMAS-SIERRA RURAL ELECTRIC COOPERATIVE, Portola, California (hereinafter called the Cooperative) upon the following terms and conditions:

1. Applicant agrees to comply with and be bound by the Articles of Incorporation, the By-Laws of the cooperative and any amendments thereto, P.U.C. Rules and such Rules and Regulations as may be adopted from time to time by the Cooperative.
2. Applicant agrees, when service becomes available, that all electric energy used on the premises described below will be purchased from the cooperative and will be paid therefore monthly at rates which will be fixed by the Board of Directors of the Cooperative.
3. Applicant Agrees:
 - a. To pay to the Cooperative the sum of \$5.00, which will constitute the Applicant's membership fee.
 - b. To deposit with the Cooperative such consumer's deposit as is required. It being expressly understood that such deposit shall be non-interest bearing.
 - c. That fee specified in (a) shall be refundable upon termination of membership except in the event that the Applicant fails to fulfill his contract with the Cooperative as provided in the By-Laws and that deposit specified in (b) shall be refundable to Applicant upon termination of service except any portion applicable to the payment of bills due Cooperative.
4. The Applicant will cause his premises to be wired in accordance with wiring specifications approved by the National Electric Code and all applicable Government Codes.
5. The acceptance of this application shall constitute an agreement between the Applicant and the cooperative, and the contract for electric service shall continue in force from the date the service is made available by the Cooperative to the Applicant and thereafter until cancelled by notice by either party to the other.
6. It is expressly understood that under law, Applicant's private property cannot be attached for any debts or liabilities of Cooperative and that becoming a member, Applicant assumes no personal liability or responsibility whatsoever for such debts.
7. Applicant consents to be contacted by the Cooperative at any contact phone number(s) provided to the Cooperative, via automated calls for the purpose of providing account notices including, but not limited to, billing reminders, collections and outage notices and updates.
